This is an agreement between TRAPÈZE LE VOLTIGEUR (9120-3208 Qc.inc) Laval, a legal entity incorporated under the laws of Canada, which offer equipment and services necessary for participation in the Flying Trapeze, hereinafter called the provider and :

A person wishing to participate in the Flying Trapeze hereinafter called the "Trapeze artist". The "Trapeze artist" was asked to participate in activities offered by the Provider, specifically to climb and swing from the platform with the trapeze help and the Provider has agreed to this request by these conditions:

1. The trapeze artist has seen and scrutinized the equipment that show the trapeze and he is satisfied, the trapeze artist is besides conscious and accepts the risks and dangers that are linked to participation in the Flying Trapeze and hereby agrees to assume the responsibility for all risks of accident or injury that may occur as a result from the execution of the Flying trapeze by the trapeze artist.
2. The Trapeze artist renounces to exercise or to execute against the Provider, its agents and employees, agents or representatives, any action at law, appeals, lawsuits, contractual commitments, complaints or claims whatsoever which holds the trapeze, hold or may hold, for any reason whatsoever, including negligence of the Provider, its agents and employees. The Trapeze agrees to make no claim against any person, natural or moral, which could initiate recourse against the Provider, its agents and employees.
3. Notwithstanding the foregoing, and without prejudice, the Trapeze artist agrees to indemnify the Provider, its agents and employees, and exempt them from any responsibility for any loss or expense incurred by the provider due to a third party action, representatives or estates resulting directly or indirectly to participation in the Flying Trapeze by the Trapeze artist.
4. The Trapeze artist declared that she or he is sane and healthy and suffer no disease that could endanger his physical health before, during or after the enforcement of Flying Trapeze.
5. The Trapeze artist agrees that, hereby, the provider denies any statement about the dangers involved in flying trapeze and that the participation in flying trapeze can be the cause of injury.
6. The Trapeze artist says he has read the MOU, he understand that this is a complete and final renunciation of any prosecution in damage for property loss and injury resulting its participation in an activity offered by the Provider, and sign the MOU on his own free will, knowing that by the very fact, it formally releases the Provider, its agents and employees from any liability in respect of any loss or a shame he could be victim.
7. The Trapeze artist allows the provider to use, for advertising purposes, any photograph or video in which the trapeze artist may appear.
